

TERMS AND CONDITIONS FOR 2010

Reservation and Payment

Deposit: \$300 per person with a completed ChinaPlus Tour Reservation Form is required at the time of booking. Upon receipt of deposit and the Reservation Form, ChinaPlus will send out the confirmation letter with invoice, China travel Q&A, Chinese visa application form and information.

Final payment: The full payment must be received by ChinaPlus 90 days before the tour departure date. Failure to comply with this requirement will result in \$50 (per person) late payment fee.

Reservation made within 90 days before departure should pay in full plus \$50 (per person) processing fee for late booking.

For payment by checks, please make checks payable to ChinaPlus, Inc. For payment by credit card (VISA and Master Card only), please obtain an Authorization Form from ChinaPlus. 3% surcharge applies for credit card payment.

Important Note: The name, passport number and date of birth on your Tour Reservation Form should be exactly the same as written in your passport which you will travel with. ChinaPlus is not responsible for denied boarding or tickets re-issue cost due to incorrect information on your Tour Reservation Form.

Payment schedules for private groups will be set case by case.

Tour Prices

The tour prices are based on two persons sharing one standard room and a minimum of 10 full-paid participants traveling together for the entire trip. If a group falls below 10 participants, we will keep the tour with additional charge, and/or adjust the tour inclusions, or switch to another departure date (tour price for the new departure date will apply). A group under this situation will be handled case by case and a notice will be sent to all the tour members at appropriate time.

Tour Price Inclusions

The tour prices for all the scheduled tours include the land programs, domestic airfare for destination cities, cruise cost (if applicable) and the airfare for departure from Los Angeles (or San Francisco depending on the flight schedule of ChinaPlus designated air carrier), and fuel surcharges. The details of inclusions are listed in each of the tour itineraries. Tips for group luggage delivery (one piece per person) in Mainland China for groups with a ChinaPlus tour director will be taken care of by the tour director.

Tour Price Exclusions

Government imposed taxes and fees including the September 11 Security Fee (total amount is listed under the tour prices of each itinerary) These will be listed separately on the invoice and are subject to change.

Chinese visa and handling. Chinese visa fee: \$140 per person (subject to change and will be listed separately in the invoice). Visa handling through ChinaPlus: \$55 per person.

Travel insurance. We highly recommend the purchase of travel insurance to protect you and your investment. Please refer to the next page for the plan coverage and rate of the Custom Travelite for ChinaPlus travelers provided by Travelex. Optional programs. Costs for any optional programs are on your own.

Gratuities. Tips for ChinaPlus tour directors, local guides, drivers and cruise staff are on your own. Tips for luggage delivery in Hong Kong and for groups without a ChinaPlus tour director are at your own expense.

Single Room Supplement

Single room can be arranged upon request based on availability. Single supplement applies to single room occupancy (refer to the amount of single supplement listed in each tour itinerary). Single supplement also applies to single room occupancy resulted from the cancellation of the travel companion.

Airline Tickets Arrangements

Air tickets on ChinaPlus designated airlines based on tour schedule. ChinaPlus will select one air carrier as the designated airlines for each group at its sole discretion. Airline tickets (economy class) will be booked based on the passenger's request on the Tour Reservation Form **and** flight availability of the designated airlines for the group. The flight schedule will strictly follow the routes and rules of the designated air carrier. Tour members departing from areas other than the West Coast may or may not travel via LAX (or SFO). Detailed flight schedule will be provided about 75 days before departure.

Air tickets on ChinaPlus designated airlines but not on tour schedule. ChinaPlus can arrange airline tickets on dates other than the scheduled tour date upon request 75 days before departure based on seat availability. The client is responsible for additional air cost.

Airfare add-on. Airfare add-on is required for departure from cities other than LAX (or SFO). ChinaPlus offers low airfare add-on for departure from most cities in the U.S. The add-on airfare only applies to the available connecting flights operated by the designated air carrier for the group at the time of tickets booking. For details, please contact ChinaPlus.

Air tickets on air carriers other than ChinaPlus designated airlines. ChinaPlus offers custom air reservations for tour members who prefer an air carrier other than the airlines designated for the group. The client is responsible for additional air cost. A written request for such air arrangements is required 75 days before departure and such bookings are based on seat availability.

Connecting flights on your own. If you let ChinaPlus handle your air tickets from LAX (or SFO) but you handle the connecting flights from your home city, we highly recommend that you not pay for connecting flights until you have received the written confirmation from ChinaPlus for your international airline tickets reservation. This is to avoid possible airline penalty for you since the tour itineraries and group flight schedules may change in case of unexpected circumstances. However, you are responsible for any cost and airline penalty incurred in case of the tour dates and itinerary change.

Land-only package. For land-only package (excluding international airfare), deduct \$550 from the list tour price. If you buy land-only package, you are responsible for any cost and airline penalty incurred in case of the tour dates and itinerary change.

Airline tickets upgrade. Request for airline tickets upgrade should be sent to ChinaPlus in writing 75 days before departure. Space is based on availability and airfare is subject to change. For upgrade with mileage points, the client needs to take land-only tour package from ChinaPlus and handle the international airline tickets directly with airlines.

Change for Airline tickets arrangements. Any change on airline tickets after the tickets are booked is subject to availability. Additional airfare and airline penalty plus \$50 (per person) service fee will apply for any change.

Airport Transfers

Initial arrival in Mainland China. Guide meet and group airport/hotel transfer will be provided for a group of minimum six pax arriving in Mainland China on the same flight of ChinaPlus designated airlines on the scheduled tour arrival date with tickets purchased through ChinaPlus; for a group less than six pax, guide meet will be arranged but the airport/hotel transfer is at the expense of the clients.

Final departure from Mainland China. Group hotel/airport transfer will be provided for a group of minimum six pax departing Mainland China on the same flight of ChinaPlus designated airlines on the scheduled departure date with the tickets purchased through ChinaPlus; for all other situations, the hotel/airport transfer is at the expense of the clients.

Initial arrival in Hong Kong. Guide meet and airport/hotel transfer will be provided for a group of minimum six pax arriving Hong Kong on the same

flight of ChinaPlus designated airlines on the scheduled tour arrival date with tickets purchased through ChinaPlus; for a group less than six pax, airport/hotel shuttle bus will be arranged and paid by ChinaPlus.

Final departure from Hong Hong. Group hotel/airport transfer with guide will be provided for a group of minimum 10 pax departing Hong Kong on the same flight of ChinaPlus designated airlines on the scheduled tour departure date with the tickets purchased through ChinaPlus; for a group less than 10 pax, the hotel/airport shuttle bus will be arranged and paid by ChinaPlus.

Airport/hotel/airport transfers on your own. You need to handle airport/hotel transfer yourself for initial arrival and hotel/airport transfer for final departure if you take land-only package, or your arrival/departure date differs from the scheduled tour date.

Baggage policy on flights in China

On flights within China, the free allowance for checked baggage per person is limited to one piece not to exceed 44lb in weight and 62 inches with linear dimensions. Overweight baggage will result excess baggage fees. The free allowance of hand carry-on per person is one piece (7 1/2 x 15 1/2 x 21 1/2) not to exceed 11lb. The tour package includes baggage handling for one checked baggage per person. Hand carry-on should be always handled by the possessor. Extra charge will apply to additional baggage handling. As required by China aviation authority, checked baggage must be locked. All baggage is at owner’s risk throughout the tour. ChinaPlus will do all the best to take care of the clients’ baggage, but is not responsible for loss, theft, or damage. Travel insurance with baggage coverage is highly recommended.

Passport and Chinese Visa

A passport valid at least six months beyond the date of tour completion is required and there are at least two blank pages marked “Visas”. ChinaPlus will provide the visa application forms and necessary information upon receipt of tour reservation and deposit. Visa can be applied by yourself or via ChinaPlus. Failure of visa obtainment is the client’s responsibility.

Vaccinations

Vaccinations are not required by China authorities for travel to China from North America. Should you have special health concerns, please check with your health consultant.

Health Requirement

All the tours listed in the brochure are leisure tours. However, some sightseeing programs include considerable walking and steps. So these tours are recommended only to travelers who can handle walking and steps without assistance. Tours including Tibet will reach an altitude of 12,000 ft. Should you have any concerns, please consult your health consultant.

Tour Director

A Chinese-English bilingual professional tour director will escort each group with minimum of 10 full-paying participants traveling together for the entire tour (If a tour director is requested by a group less than 10 participants, a tour director can be arranged at additional charge). For a private group (same itinerary as listed in the brochure but exclusively for a community) or a custom tour (itinerary different from the brochure), a tour director will be arranged based on the agreement with the group organizers.

Cancellation Fees

Fees indicated in the following chart will apply to cancellations for any reasons. The cancellation will be effective on the date of receipt of written cancellation notice from the client. Certain supporting documentation may be required for cancellation processing. All international airline tickets (including tickets for connecting flights) purchased through ChinaPlus are highly restrictive (mostly are non-refundable). After the airline tickets have been issued, the actual cost of the airfare will be deducted from the applicable tour cancellation refund. Airfare refund (if any) is available only if received from the airlines. .

Anytime 91 days before departure.....	50% of deposit (minimum \$150)
90-61 days before departure.....	35% of full payment
60-45 days before departure.....	50% of full payment
44-35 days before departure.....	60% of full payment
34-15 days before departure.....	80% of full payment
Within 14 days before departure.....	100% of full payment

There is no refund for no-shows or any unused portion of the trip, such as missed transfers and/or missed flights, any unused meals, missed tours, unused entrance fees, and hotel accommodations. If a client changes the itinerary for any reasons during the tour, the client is responsible for all the expenses for the new itinerary. The payment for the missed portion of the original itinerary is non-refundable.

Limitation on Liability

Payment of deposit represents an acceptance by the traveler of the terms and conditions as stated. The terms and conditions apply to all the tours listed in the brochure and private/custom tours as well unless stated otherwise. ChinaPlus, Inc. of Irving, Texas (hereinafter referred to as “CPI”) purchases transportation, hotel and cruise accommodations, restaurant services and other services from various independent suppliers that are not subject to its control. CPI cannot, therefore, be liable for any flight delay or cancellation, death, personal injury or other loss that may occur due to any act or omission of such a supplier, or by reason of any other event, which is out of CPI’s control. CPI reserves the right to substitute the tour itineraries, flights, hotels and cruise ships due to conditions beyond its control and reserves the right to correct any printing errors in the brochure and other tour documentation. By utilizing the services of CPI, you agree the exclusive venue of whatever nature arising out of this contract shall be the State of Texas and such claim, actions of proceedings shall be determined according to the laws and jurisdiction of the State of Texas. For claims to be considered, they must be received by CPI in writing within 30 days after the tour completion date.
